Loxahatchee River Watershed Restoration Project (LRWRP)

Purpose: The LRWRP aims to restore and sustain the overall quantity, quality, timing, and distribution of fresh waters to the federally designated "National Wild and Scenic" Northwest Fork of the Loxahatchee River.

Lake Okeechobee Watershed Restoration Project (LOWRP)

Purpose: The LOWRP will improve water levels in Lake Okeechobee; improve the quantity and timing of discharges to the St. Lucie and Caloosahatchee estuaries; improve water supply for existing legal users of the Lake Okeechobee Service Area (LOSA); and increase spatial extent and functionality of wetlands.

Purpose: The invasive Burmese python is reproducing in south Florida and represents a significant threat to the Everglades and the entire south Florida ecosystem. Records since 1979 indicate over 9,000 Burmese pythons have been removed from Florida. The support and leadership of Governor DeSantis has helped combine the efforts of the National Parks Service, the South Florida Water Management District and the Florida Fish and Wildlife Conservation Commission, into a cohesive team dedicated to managing pythons in South Florida. This presentation provides a summary of the mission and current efforts of the three partners and future opportunities to control pythons in south Florida.
